GUARANTY AGREEMENT

NOW, THEREFORE, in consideration of such credit extended and/or to be extended in it's discretion by Tri-State to the Borrower, the undersigned (who if two or more in number, shall be jointly and severally bound) hereby unconditional guarantees to Tri-State and its successors, endorses and assigns the punctual payment when due, with interest accruing thereon at the rate 1.5 % (per month) of all debts and obligations of the Borrower, plus attorney fees if this agreement is enforced by or through an attorney at law.

The undersigned consents that the time or place of payment of any debt of the Borrower may be changed or extended in whole or in part: that the Borrower may be granted indulgences generally: that any party liable for payment (including but not being limited to any co-guarantor) may be granted indulgences or released: that neither the death, bankruptcy nor disability of any one or more of the grantors shall effect the continuing obligation of any other grantor; that no claim need be asserted against the personal representative, guardian, trustee in bankruptcy or receiver of any deceased, incompetent, bankruptcy or insolvent guarantor, and that the undersigned shall remain bound thereon, notwithstanding any such exchange, compromise, surrender, extension, modification, indulgences or release.

The undersigned expressly waives: (a) notice of acceptance of this guaranty and all extensions of credit to the Borrower, (b) presentment and demand for payment of any debts of the Borrower, (c) protest and notice of dishonor or of default to the undersigned or to any other party with respect to any of the debts of the Borrower or with respect to any security thereof, (d) all other notices to which the undersigned might otherwise be entitled, and (e) demand for payment under this guaranty.

This is a guaranty of payment and not of collection. The liability of the undersigned on this guaranty shall be direct and immediate and not conditional or contingent upon the pursuit of any remedies against the Borrower or any other person. The undersigned waives any right to require that an action be brought against the Borrower any other person or to require that resort be to any security. If the debts of the Borrower are partially paid through the liquidation of security, the undersigned shall be liable for any balance of such debts.

This guaranty shall be binding upon the undersigned, his personal representatives, successors and assigns unless and until (and then only with respect to future transaction or commitments) terminated by notice to that affect sent by certified mail, addressed to Tri-State at the office of Tri-State extending credit under this guaranty agreement.
